REQUESTS FOR ADMISSION

REQUEST FOR ADMISSION NO. 11: Admit that you physically assaulted Laurie Rushing on November 21, 2017, at a funeral service.


REQUEST FOR ADMISSION NO. 12: Admit that you have stalked Laurie Rushing.
