<u>COUNT 1.</u> Did unlawfully and feloniously on or about March 5, 2017, **5-13-204(a)(3). Aggravated Assault-**under circumstances manifesting extreme indifference to the value of human life, he purposely impedes or prevents the respiration of another person or the circulation of another person's blood by applying pressure on the throat or neck or by blocking the nose or mouth of the other person; a Class D felony
