NO CONTACT ORDER

This Court has jurisdiction over this matter, and hereby issues a No Contact Order as follows:


THIS COURT ORDERS: (only items checked shall apply)

- X_ 1. You are prohibited from contacting, directly or indirectly, SETH WILSON in any manner.
- X_ 2. You are ordered to stay away from the victim's place of employment and/or school.
- X_ 3. You are ordered to immediately leave and stay away from the victim's residence or anywhere else you may have reason to know the victim may reside. You are ordered not to shut off, or cause to be shut off, any utilities or mail delivery to the victim, and not to interfere in any way with the victim's right to possess that residence.
- X_ 4. You are prohibited from approaching or communicating with SETH WILSON, either through a third party or by telephone, electronic communication, or in writing.
- X_ 5. You are ordered to stay at least one thousand five hundred feet (1,500') from SETH WILSON.
- ___ 6. You are ordered not to possess any weapons, firearms or ammunition.
- ___ 7. You are ordered not to ingest alcohol, illegal drugs, and/or the following controlled substances _____
- ___ 8. You are required to report to the Court within 24 hours of being notified for random drug testing. You must supply the Court with a physical address, phone number, or other means to contact you. If you move and/or change phone numbers you must immediately notify the Court of these changes. Failure on your part to provide this information will be a violation of the terms and conditions of this no contact order.

This No Contact Order shall remain in effect for not more than one (1) year from the date of issuance or, if the original charge is adjudicated with a finding of the defendant's guilt, from the date of sentencing.

Violation of any of the above terms and conditions of this No Contact Order is a Class A misdemeanor, punishable up to one (1) year in the county jail and/or a fine in the amount of \$2500.00 in violation of

A.C.A. 16-85-714. In addition, if the Court finds that the defendant violated any of the above terms and conditions of this No Contact Order, the Court may impose different or additional conditions of release or revoke his or her appearance bond.
