JUDGMENT OF PATERNITY

Now on JANUARY 04, 2012, this cause comes on to be heard with the State of Arkansas, Office of Child Support Enforcement appearing by its attorney, SHERRI C. KARBER, and ROBERT ALTES

From the pleadings, genetic test results of 99.99%, and other matters properly before the Court, the Court Finds and Orders as follows:

1. ROBERT ALTES is the father of the following minor child(ren) born out of wedlock to KRISTEN M. FOSTER:

2. The State of Arkansas, Office of Child Support Enforcement is involved in the establishment of paternity and a support order herein pursuant to its responsibilities under Ark. Code Ann. § 9-14-210(d) and § 9-10-104 under which KRISTEN M. FOSTER is the recipient of services under Title IV-D of the Social Security Act.

3. ROBERT ALTES owes a continuing duty of support to the aforementioned child(ren); ROBERT ALTES's current income after deductions permitted by Administrative Order 10 is \$560.00 WEEKLY. Pursuant to the Arkansas Family Support chart a rebuttable presumption has been created that \$ 151.00 WEEKLY is a reasonable amount of support for ROBERT ALTES to pay. Therefore, ROBERT ALTES is hereby ordered to pay the sum of \$151.00 WEEKLY beginning JANUARY 13, 2012.

4. ROBERT ALTES is ordered to pay the sum of \$30.20 WEEKLY, in addition to current support, to be applied to any judgment. Said Judgment is granted to OCSE on behalf of the custodian of the minor child(ren) herein who has assigned this right to or has contracted with the OCSE for collection of said amount. Said Judgment is subject to execution, garnishment, reduction through income withholding, and enforcement through any and all other collection remedies available to the OCSE.

5. If at any time payments are not being made through income withholding, ROBERT ALTES shall mail all child support payments to the Arkansas Child Support Clearinghouse, P.O. Box 8124, Little Rock, Arkansas, 72203 and shall include the OCSE case number, 750573892, on the payment. Payments may also be made online by going to [www.childsupport.arkansas.gov](http://www.childsupport.arkansas.gov).

6. Pursuant to Ark. Code Ann. § 9-14-107 as amended by Act 337 of 2003, ROBERT ALTES is directed to provide to the custodial parent and the Office of Child Support Enforcement proof of income for the previous calendar year. Furthermore, but not more than once per year, the custodial parent may request in writing, sent by certified mail, proof of ROBERT ALTES's income for the previous calendar year. ROBERT ALTES is directed to respond to such a request and provide proof of previous year's income to the custodial parent by certified mail within 15 days from the receipt of such a request.

7. The child support obligation shall terminate as provided for by Ark. Code Ann. § 9-14-237.

8. Effective immediately, pursuant to Ark. Code Ann. § 9-14-218(a)(1), a payor as defined by Ark. Code Ann. § 9-14-201, including the Arkansas Department of Workforce Services, shall deduct: from money, income, or periodic earnings due the noncustodial parent the amount of the periodic current child support payments ordered herein and an additional twenty percent of the current child support payments to be applied toward liquidation of any arrearage presently due or which may accrue in the future, unless another amount is specifically ordered paid herein toward liquidation of arrearage; and from any lump-sum payment as defined in Ark. Code Ann. § 9-14-201, the full amount of past due support owed by the noncustodial parent not to exceed fifty percent of the net lump sum payment.

9. ROBERT ALTES is ordered to provide and maintain health care insurance for the benefit of the minor child(ren) when reasonably available through ROBERT ALTES's employer.

x   ROBERT ALTES currently is employed and has health care insurance available to him at a reasonable cost. Cost of said insurance is \$ 0.00 WEEKLY and has been considered in the calculation of the child support obligation.

       Health care insurance is currently unavailable to ROBERT ALTES. ROBERT ALTES will notify the Office of Child Support Enforcement should health care insurance become available to him and take all steps necessary to add the child (ren) to the insurance or request a hearing on the reasonableness of the cost of the health care insurance.

ROBERT ALTES will complete all necessary enrollment requirements for health care insurance coverage and provide the Office of Child Support Enforcement and the custodial parent with proof that coverage has been secured. ROBERT ALTES is to assist the custodial parent and/or State of Arkansas, Office of Child Support Enforcement in the successful completion and submission of all claims for benefits pursuant to such coverage and will pay over to the State of Arkansas, Office of Child Support Enforcement, custodial parent or medical services provider benefits received pursuant to claims filed on behalf of the minor child(ren). Pursuant to Ark. Code Ann. § 9-14-506, immediately upon receipt of the National Medical Support Notice, ROBERT ALTES's present and/or future employer is directed to deduct from money, income, or periodic earnings due ROBERT ALTES an amount which is sufficient to provide for premiums for health care coverage for the minor child(ren) listed herein offered by the employer and forward that amount to the health care plan administrator. The health care plan administrator shall complete the enrollment and notify the custodian and child that coverage is available or when it will become available. The health care plan administrator shall provide to the custodian, within 40 business days after the posting date of the National Medical Support Notice, a description of the coverage, the effective date of the coverage and any forms necessary to effectuate the coverage.

10. ROBERT ALTES shall pay the cost of the action in the following amount(s):

- \$ 0.00 for Clerk's filing fee,  
 \$ 0.00 for service of process,  
 \$ 0.00 for paternity testing fees,  
 \$ 0.00 for Attorney fee,  
 \$ 0.00 Other: \_\_\_\_\_.

Pursuant to Ark. Code Ann. § 9-14-804(b)(1), ROBERT ALTES shall pay the annual administrative fee of \$36.00 to the Arkansas Child Support Clearinghouse until no children remain minor, the child support obligation is extinguished, and any arrears are completely satisfied.

Any payment(s) shall be made to the Arkansas Child Support Clearinghouse, P.O. Box 8126, Little Rock, AR 72203. Each payment should include the OCSE case number 750573892 and a designation on the payment of "Payment on FEES/COST".

11. ROBERT ALTES shall keep the Office of Child Support Enforcement advised at all times of current address, place of employment, whether health insurance coverage is available, and the policy information.

12. The Arkansas Department of Health, Division of Vital Records is hereby directed to correct the birth certificate of the minor child(ren) to show the ROBERT ALTES as the father of the minor child(ren) listed in paragraph one (1) above.

13. Pursuant to Ark. Code Ann. § 9-10-113, KRISTEN M. FOSTER, the woman giving birth to the child(ren) of this action, has legal custody of the minor child(ren) until the child(ren) reaches the age of eighteen (18) years unless a court of competent jurisdiction enters an order placing the child(ren) in the custody of another.
