Before my arrival, I was informed the suspect, Max Rodriguez, had left the residence in a Gray Toyota 4 Runner. After searching the area, I made contact with Seth Wilson and Sarah Bradshaw, victims. Seth stated he had been attacked by Max at the front door and at once he got away, he started videoing Max screaming at him. I asked to see the video and saw Max pacing around yelling. You can then see Sarah come into view by Max who is now opening the door to his vehicle. You can then see Sarah take off running and Max turn around with a black handgun. The

video goes out of view as Seth is trying to get into his car. It then appears there is a struggle and the video ends.

Seth stated him and Sarah were in an argument when he was going to leave. He said the argument included him accusing Sarah of having an affair with Max. Max and Sarah had dated in the past. Seth said Sarah called Max for some unknown reason and was letting him listen to them arguing. When Seth went to leave just a few minutes later, Max was standing at the front door. Sarah had opened the door and Max attacked Seth. Seth stated Max was hitting him in the head and had thrown him to the ground. Seth said he got away and started videoing him yelling and making threats. When Max noticed Seth videoing, he went to his vehicle and pulled a gun out. He stated he pointed the gun at him at least twice and came to the vehicle where he had been trying to get in to get away from Max. He said Max started pulling on the door before he was able to get it shut completely and tried to get his phone away from him. He said he pulled his door open and it damaged the bottom of it. When Max wasn't able to get the phone, he left.

Sarah gave the same accounts only adding that she did not ask Max to come over. She stated while they were dating, he had hit her on a few occasions and after they broke up had just randomly showed up where her and Seth were. Sarah said she ran back in the house because her two daughters were in there and she was afraid of what Max was going to do.

Seth had cuts on his right leg, his left ear was red, and he had a large knot on the left side of his head. There were also what appeared to be red marks on his neck. The bottom of the door on his car was bent back where it had been pulled into a rock barrier.

Both Sarah and Seth gave written statements which will be entered into evidence. Pictures were taken of the injuries and the car door. I was also able to get a copy of the video which I will have CID burn a copy for prosecution.

A BOLO was put out for Max. Alma PD and Fort Smith PD advised they would be attempting to locate Max at known addresses in their cities.
