Narrative - Jackson, Dave - 4/7/2006 (Initial)

On 04/07/2006 at around 1830 I responded to the Fort Smith Sheriff's Office in response to a complaint of Aggravated Assault. The complainant, Jerry Clardy, said that when he was trying to collect his last paycheck from the usual individual, Bill, he was referred to Robert Altes. Mr. Clardy stated that when he asked Mr. Altes for his paperwork and his payroll information that was visible on Mr Altes' desk, he then reached for the payroll information and told Mr. Altes that he would give the paperwork to his last supervisor, Bill. At this point Mr. Altes pulled a .357 Magnum (revolver) and pointed it at him while telling him to get away from his desk and Mr. Clardy immediately dropped the paperwork and walked away while Mr. Altes had the handgun pointed at him. Mr. Clardy then left the scene and came directly to the Sheriff's Office to report the incident.

Narrative - Cox, Steve - 4/10/2006 (Initial)

On the above date dispatch advised of a name and number for Robert Altus. I contacted Mr Altus by phone and he stated that there had been an incident at his office. He stated that one of his employees (Jerry Clardy) had been terminated. Mr Altus stated that Mr Clardy was a contract employee and that this date was his last day to work. Mr Altus stated that he was handing out the paychecks for his employee's but Mr Clardy's check had a hold put on it by the contract company because of a vehicle damaged by Mr Clardy. Mr Altus stated that when he told Mr Clardy this information Mr Clardy reached across the desk and pulled the stack of paychecks from his hands and stated that he would get his money. Mr Altus stated that because of Mr Clardy's size he (Robert Altus) was afraid for his safety. Mr Altus stated that he then reached into his desk and took out a .357 revolver and placed it on the desk and told Mr Clardy to leave. Mr Altus stated that Mr Clardy then returned the checks and left the building. I explained to Mr Altus that I needed to talk to him about this incident in person. Mr Altus stated that he was about to leave his office and pick up his children. I asked him to call me after he picked up his children and he stated that he would. Mr Altus never returned my call so that we could meet and discuss the incident. END OF NARRATIVE

Narrative - Nickson, Kevin - 4/10/2006 (Initial)

Time: 0925 hrs

I, Lt. Nickson, made contact with the listed suspect, Robert Altes, by telephone. I advised him that I would be looking into this report and requested to meet with him. He advised me that he would be at his office all day. I advised him that I would be coming to his office to take a statement this morning.

I called the complainant's house and was advised that he was not home. I was advised that he would be home approximately 1200 hrs. I left a message to have him call me in reference to this case.
